FACILITY USE AGREEMENT & ACKNOWLEDGMENT OF RISK

Entry Form (Guests, Day/Week/Month Passes, Members, and Visitors)

1) Agreement to Terms & Rules. I received or was given access to the current SPRFC Terms (digital or paper). I agree to comply with the Terms, posted signage, and staff instructions. All safety restrictive rules apply unless management provide a written exception.

2) Voluntary Use; Assumption of Inherent Risks. My minor child (if applicable) and I voluntarily enter and use the Facilities (including racquetball, wallyball, fitness equipment, locker rooms, and the pool area). I understand athletic/fitness activities and pool areas involve inherent risks that may cause serious injury, illness, disability, death, or property damage.

Examples of inherent risks include:

- slips, trips, and falls (especially around wet areas);
- overexertion, improper technique, or aggravation of pre-existing conditions;
- equipment misuse or malfunction; dropped weights; pinch points;
- being struck by balls/racquets, collisions, or impacts with walls/floors;
- water hazards including drowning and exposure to pool chemicals/heat.

3) Health; Emergency Care. I am responsible for knowing my health limits and consulting a physician if needed. I will stop if I feel unwell (e.g., chest pain, dizziness, shortness of breath). I authorize emergency medical care for me (or my minor child) if reasonably necessary, and I am responsible for related costs.

4) Key Rules (Review the Full Club Terms and Rules Posted): check in before use; present valid photo ID when requested (may be scanned/verified); follow staff directions; use equipment only as intended; wear appropriate attire/footwear; not run/horseplay (especially on the pool deck/in locker rooms); not use equipment or engage in activities while impaired; report hazards/equipment issues; not allow unauthorized entry/tailgating; and comply with alcohol policies (21+ only; no one under 21 may sit at the bar counter).

PHOTOGRAPHY / RECORDING NOTICE (see full Terms, Photography and Media Rules): I agree no photography, video recording, audio recording, video calls, or speakerphone use is allowed in locker rooms, restrooms, or private/restricted areas. Photography/recording elsewhere requires prior Club Management permission and may be limited or stopped by staff. The full Terms also address Club promotional/business/safety media use, written opt-out notice, and video surveillance.

5) Guests and Minors: Only a parent or legal guardian may register or sign on behalf of a minor. Any guest under 18 must be registered in person at the Club with a parent or legal guardian present, unless valid parent or guardian authorization is already on file. A minor may complete this Agreement online, but a parent or legal guardian must sign in person at the Club. Children under age 13, whether Guests or Members, must be always supervised by a parent or legal guardian, without exception, except as may be expressly permitted under a separate Club-approved program agreement. Minor access to specific rooms, equipment, pool areas, and other portions of the Facilities is strictly limited by Club policy. All minor use of the Facilities is subject to the SPRFC Terms and Club Rules, posted policies, staff instructions, and any additional restrictions imposed by Club Management. Parents and guardians remain fully responsible for the supervision, safety, conduct, and compliance of their minor child(ren) at all times.

6) Damage; Indemnity for Misconduct; Personal Property; Disputes. I am responsible for damage caused by my (or my minor child's) intentional acts or negligent misuse. To the fullest extent permitted by law, I will defend and indemnify the Club for third-party claims arising from my intentional misconduct or rule violations (not for the Club's negligence). The Club is not responsible for loss/theft of personal property. Maryland law governs; venue for disputes is Anne Arundel County, Maryland, unless prohibited by law.

7) Duration of Agreement: This Agreement applies to today's visit and, unless replaced by a newer signed agreement or required again by Club Management, applies to future authorized use of SPRFC during the signer's current continuous membership, pass period, program participation, rental/event participation, or guest/visitor access. For guests and minors, SPRFC may require a new Agreement at least every twelve months, when the form changes, when the user's status changes, when a minor turns 18, or whenever required by Club Management.

By signing this document, I acknowledge that I have been given access to the Club's Rules and Terms, understand that they apply to my use of the facility, and accept responsibility for following them, including rules regarding minors, health and emergency care, photography/recording, and the risks associated with using the Club.
